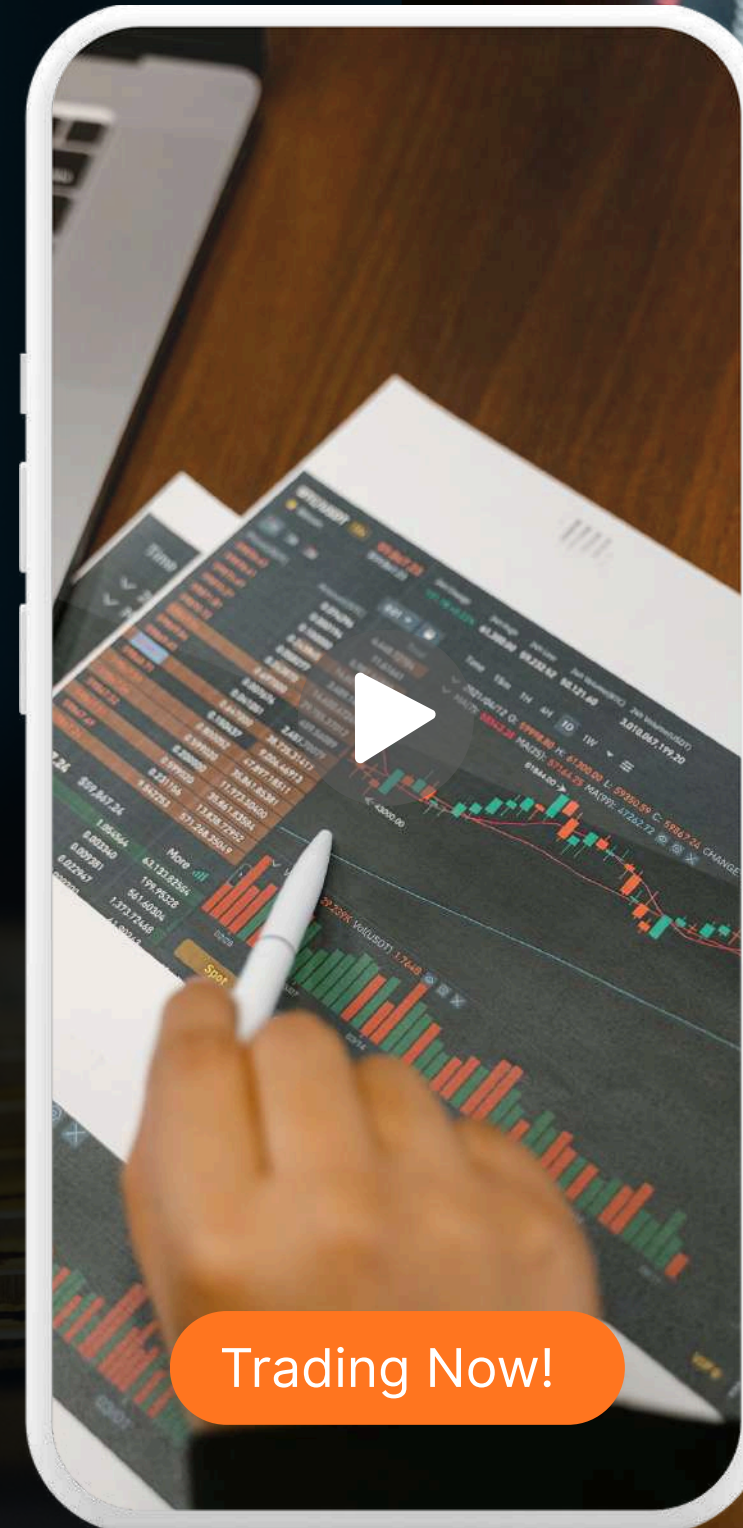
▼ COPY TRADE

On which our professional traders manage copy trades. We have different groups for copy trade from 100 dollars to 20 thousand dollars that is 10 groups.

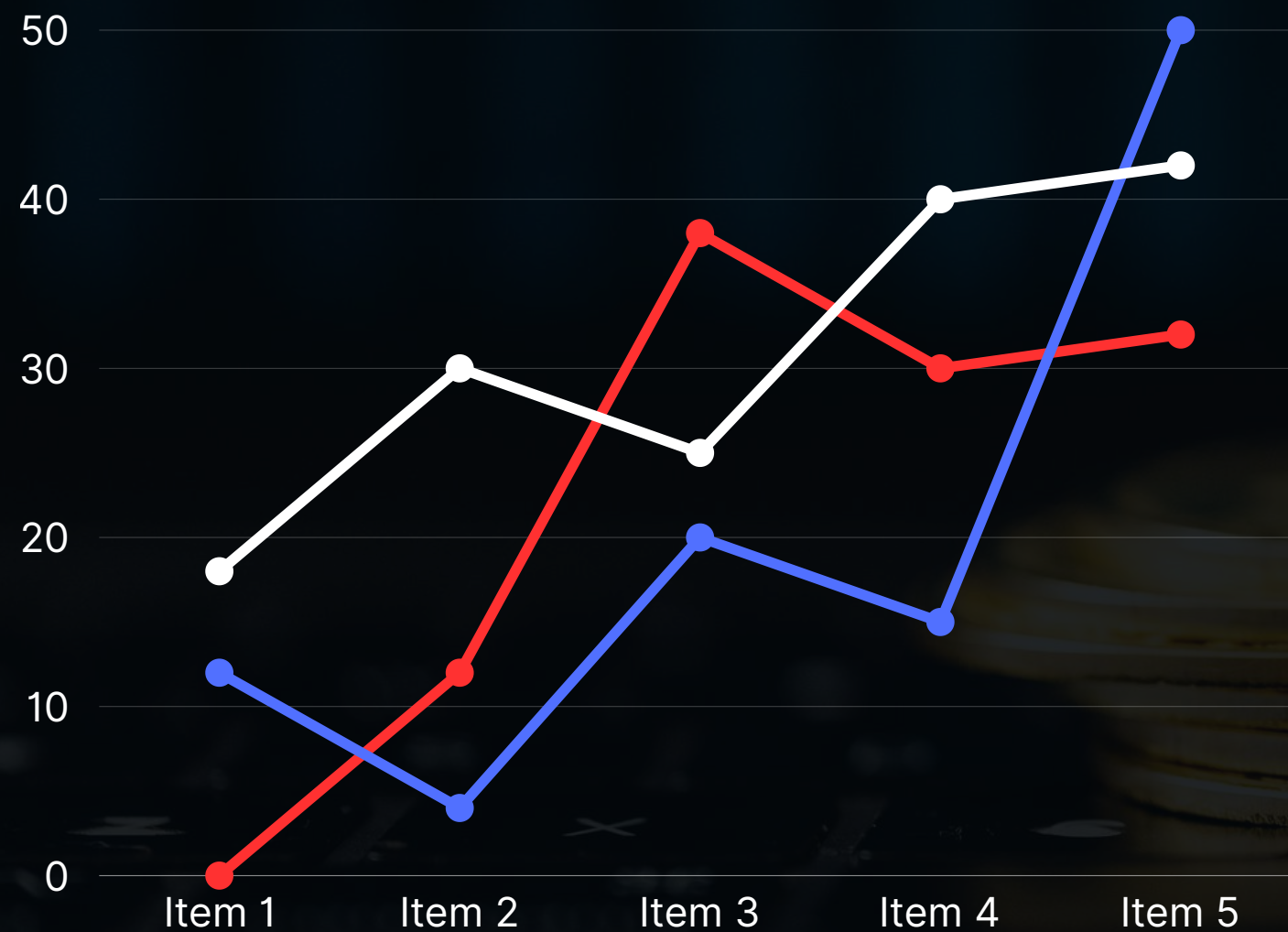
▼ RISK TO REWARD MANAGEMENT

Each of our trades is done with risk and reward in mind. Each account has a daily risk of 10%. And this 10% risk is also divided into five parts. Each trade has a risk of 2% and if five trades go from a one-to-three reward ratio, then only 2 trades can make up profit. 1% per day

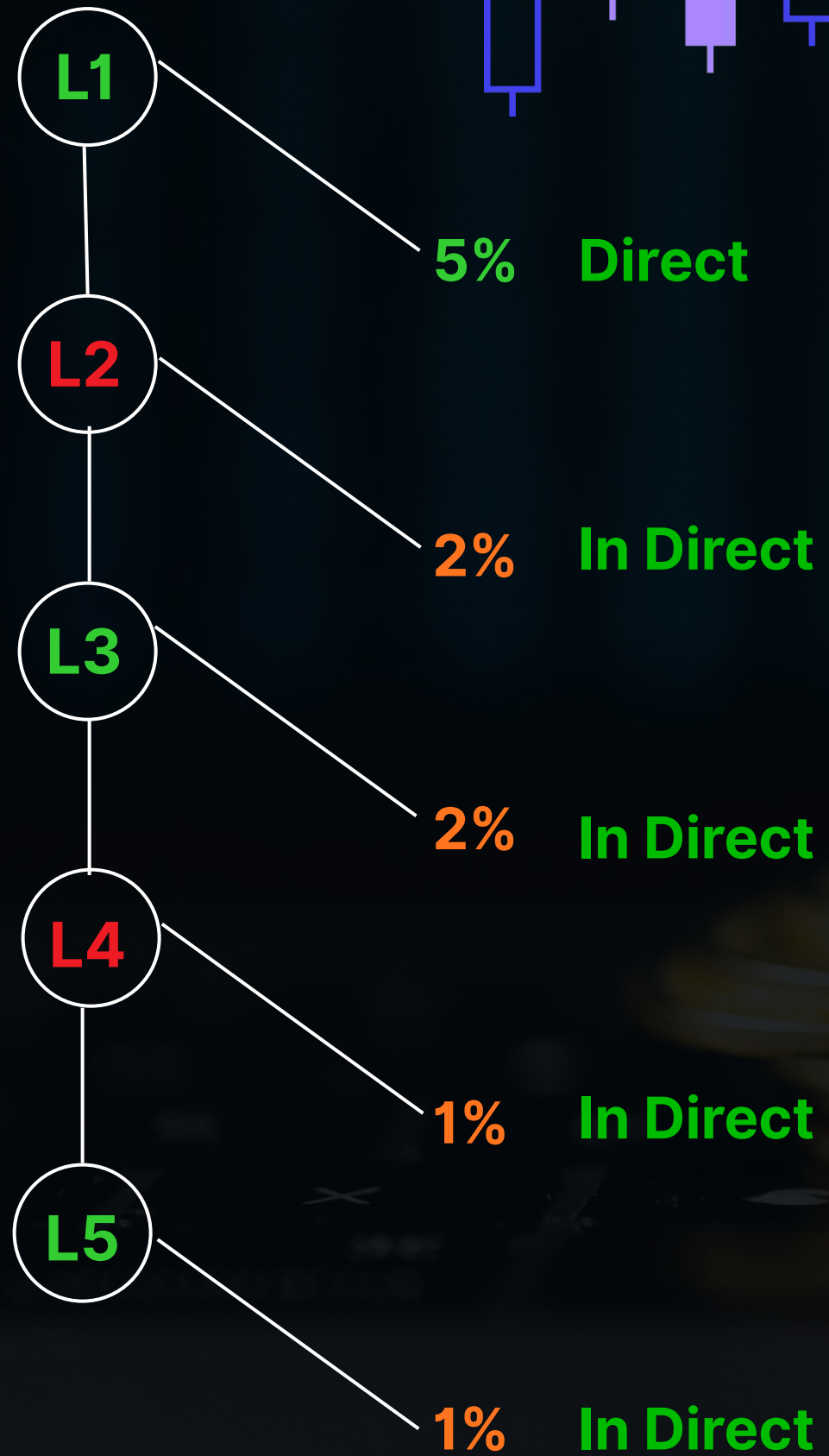

Major regulators include the Financial Conduct Authority (FCA) in the UK, the Australian Securities and Investments Commission (ASIC), and the Commodity Futures Trading Commission (CFTC) in the US. These regulations require brokers to separate client funds from their own and undergo regular audits to ensure they meet industry standards.
